SERVICING ALL DISTRIBUTION CENTERS
- **New England Motor Freight**
SERVICING DISTRIBUTION CENTERS IN DAYVILLE, CT; PERRYMAN, MD; LIVERPOOL, NY; METRO, NY; ROME, NY; and PHILADELPHIA, PA
- **Tony's Express**
SERVICING DISTRIBUTION CENTERS IN LANCASTER, CA and WOODLAND, CA
- Use LTL carriers from Preferred Carrier list to insure priority delivery appointments and unloading by trained receiving personnel.
- Shipments must not be made on a "Prepaid & Charge" or "Prepaid & Add" basis.
- Delivery appointments at Rite Aid Distribution Centers are necessary. The supplier or supplier's carrier must obtain a delivery appointment from the Rite Aid Distribution Center Receiving Department. If a carrier fails to arrive as appointed and has not notified the Distribution Center Receiving Supervisor in advance, a cancellation fee will be assessed. Rite Aid Distribution Centers require drivers to unload shipments.

- Any assessment of detention, storage, sort and segregation or unloading charges associated with prepaid shipments will be forwarded to the supplier or deducted from supplier accounts payable balances. A fee will be charged to the Supplier for any prepaid shipment appointments made and not kept.
- Rite Aid recommends the packing list be noted as a countable unit (carton/piece) of freight on the Bill of Lading.
- Consult the Rite Aid Vendor Compliance Guide for additional information regarding the use of Preferred Carriers.

Collect Supplier Shipments

Contact the Corporate Transportation Department at transportation@riteaid.com for routing instructions. Failure to receive Rite Aid specified routing will result in freight charge back plus \$100 administration fee per Vendor Compliance.

Rite Aid Backhaul Shipments
